#### IMPORTANCE OF CARING FOR GRAVES FIRST

We old Veterans and those who cherish our cause should use every effort to have these un-cared for graves attended to at once. Let us put them in condition as soon as possible and then erect monuments."



#### HISTORICAL DATES IN JANUARY

#### **January 2, 1861**

North Carolinian forces take the Fayetteville arsenal as well as Fort Macon and the forts of Wilmington.

January 3, 1861-Georgian forces claim Fort Pulaski critical to the defense of Savannah, Georgia.

January 1, 1862 - Confederate forces begin bombardment of Fort McRea in Pensacola Harbor.

January 4, 1862 - Confederate troops claim Bath, Virginia.

January 9, 1862 - The New Orleans Campaign begins.

January 19, 1862-The Battle of Mill Springs, Kentucky.

January 1, 1863-The Emancipation Proclamation goes into effect.

January 1, 1863 - Union forces flee Galveston, Texas after a surprise attack by General Magruder and his men. The city is now firmly in Confederate control.

January 21, 1863 - Confederate warships capture several Union vessels at Sabine Pass in Texas.

#### THE BATTLE OF GALVESTON



The Battle of Galveston was a naval and land battle of the American Civil War, when Confederate forces under Major Gen. John B. Magruder expelled occupying Union troops from the city of Galveston, Texas on January 1, 1863.

After the loss of the cutter *Harriet Lane*, the Union Fleet Commander William B. Renshaw blew up the stranded vessel USS *Westfield* to save it from falling into enemy hands. Union troops on shore thought the fleet was surrendering, and laid down their arms.

The bold, intrepid, and gallant conduct of Maj. Gen. J. Bankhead Magruder, Col. Thomas Green, Maj. Leon Smith and other officers, and of the Texan Rangers and soldiers engaged in the attack on, and victory achieved over, the land and naval forces of the enemy at Galveston, on the 1st of January, 1863, eminently entitle them to the thanks of Congress and the country.

The battle is sometimes called the Second Battle of Galveston



GEORGIAN FORCES CLAIM FORT PULASKI

On January 3, 1861, sixteen days before the secession of Georgia from the Union, volunteer militia seized Fort Pulaski from the Federal and. government Confederate forces, began repairing and upgrading the armament. In late 1861, the commander, Department of Georgia, General Alexander Robert Lawton would transfer to Richmond. On November 5, General Robert E. Lee assumed command of the newly created "Department of South Carolina, Georgia and Florida".

Fort Pulaski was considered invincible with its 7-1/2-foot solid brick walls and reinforcing masonry piers. General Robert E. Lee had earlier surveyed the fort's defenses with Colonel Olmstead and determined, "they will make it pretty warm for you here with shells, but they cannot breach your walls at that distance." Wide swampy marshes surrounded the fort on all sides and were infested with native alligators. No attacking ship could safely come within effective range, and land batteries could not be placed closer than Tybee Island, one to two miles away.

Repeated Union naval and amphibious assaults failed 1862–1865, both Union gunboats and ironclads repeatedly suffered

substantial damage and loss by Confederate gunnery and mines.

#### A SPECIAL WORD FOR **CONFEDERATES WHO** JOINED THE US ARMY

Being a POW was not a great way to spend your enlistment in the Civil War, no matter which side you fought on. Depending on which POW camp you ended up locked into, your chances of survival were only slightly better.

Some Confederate troops had no problem turning around and joining the U.S. Army. They were called "Galvanized Yankees."

By 1863, Union lines were becoming stricken by desertions. Coupled with the death rate and the number of wounded and

missing men, the U.S. Army in 1863 needed a solution for this coming manpower shortage in a hurry. And it wasn't just the Army fighting the Civil War who needed the help. Troops fighting Indian bands in the West needed augmentees as well.

So the Union formed the 1st Volunteer Infantry Regiment; former Confederate soldiers who had been captured, taken the oath of loyalty to the United States, and enlisted in the U.S. Army.

Starting in 1863, the former Confederates stared down the Sioux tribe in Missouri while the war back home raged on. When the Confederates heard of this, they dubbed the POWs who took the deal "Galvanized Yankees," covering themselves and their deeds in the blue of the Union, the way a metal object is galvanized with a coating of zinc.



#### ANIMALS HAD FREE RUN OF THE SQUARE

My first visit to Gilmer was about forty-five years ago, when

I came here with my father and brother on a wagon loaded with cotton and meal. My father was a ginner, as his stock in trade.

The square was really a friendly place for pigeons, ducks, geese, chickens, hogs, dogs, horses, mules, and people all mingled together with one common purpose—to profit from their labors. People were there to sell whatever they could find. The goats loved to go to court. In fact, they acted as door-bailiffs, resting in the shade of the courthouse porches, chewing their cuds, and unmindful of whether people could get into the building to testify.

Along about 1901, the city incorporated or re-incorporated and ordinances were passed to banish Mr. Goat from court. But Mr. Tom Chandler or Mr. Perry would trade in goats, and back they would come. On such occasions the Hays Studio porch was their sleeping quarters. We have gone to door many times armed with broomsticks, old shoes, buckets of water, and other weapons. Mr. Goat would be just beyond range by the time the door was opened. It is needless to say much sweeping and fumigating had to be done after the hasty departure of the unwelcome guests.



## RECOLLECTIONS OF GILMER

By Mrs. Donie Rees...A Brief History August 1946

"Old" Judge Lyons, he was a County Judge in Upshur County "an upright and honored citizen of Gilmer for about 30 years" as well as the owner of the newspaper. The printing office stood about where the post office now stands. His death was a tragic

one, and here are the details as I remember them: His partner was a man named Arthur Ashley, who resented Lyon's use of profanity, especially toward him.

Ashley's wife was teaching at Emory School about three miles away. One afternoon, soon after she and the children had returned from school, all tired out from her day's work and the walk home, her husband walked in and she went to the door to greet him with a kiss. At once he began telling her, "Judge Lyons called me a after I had warned him not to curse me. I picked up an iron side-stick," a heavy printer's tool and killed him! Then I locked the door and walked out." Mrs. Ashley fell back across the bed in a dead faint. They worked with her till they revived her, and my parents prevailed on Ashley not to leave at once, as he meant to do, but to remain overnight with his family. This he did, but in the morning he sought safety in flight. It was two or three days before Judge Lyons was missed, and officers broke down the door of the printing office and found him dead. Ashley had got away by this time. Later he was captured in Alabama and brought back here for trial, but he broke jail again on Oct. 23, 1882 and was never heard of any more. If you will go to the city cemetery you will find the grave of Judge Lyons surrounded by an iron fence, and lying in the shade of a big magnolia tree, just about thirty steps from the Coffeeville road. At the head of the grave is a weather-beaten, lichen-covered graying marble stone which reads: "My husband, J. J. Lyons, died April 5, 1882. The strife is over, the loved of years hath left me with the gathering fears to struggle darkly, and lone...." Mrs. Lyons struggled 17 years before she was laid beside the judge, and the grave stone reads: "Sarah S. Lyons, wife of Judge J. J. Lyons, died January 20, 1899." None of the stones give the date of birth or age.
