JEFFERSON DAVIS CHAIR RECOVERED

A carved limestone chair dedicated to Jefferson Davis

disappeared last month from a Confederate burial ground in Selma, Ala., where it had stood since 1893, a group calling itself White Lies Matter claimed last week to have the chair in its possession. The group threatened to turn the chair into a toilet if its demands were not met.

In late March, the United Daughters of the Confederacy reported that an ornately carved stone chair dedicated to Confederate president Jefferson Davis—and estimated by the group to be worth \$50,000—was stolen from a cemetery in Selma.

The New Orleans police said that a tip had led them to the "seemingly undamaged" chair near the intersection of Feliciana and North Galvez Streets on Thursday and that they had made plans to return the monument to its owner. The police said they had also arrested two people, Stanley Warnick, 32, and Kathryn Diionno, 24, and were seeking a third person.

Michael Jackson, the district attorney in Dallas County, Ala., said the three would face charges in Selma of extortion and theft.



HISTORICAL DATES IN MAY



<u>1861</u>

May 9 - Military assets of Texas are officially handed over to the Texas Rangers by U.S. General David Twiggs.

May 13 - Britain declares herself neutral in the American conflict and fails to officially recognize the Confederate States of America.

May 21 - Richmond, Virginia becomes the official national capital of the Confederacy of the United States.

<u>1862</u>

May 4 - General McClellan's forces take Yorktown, Virginia. Land mines are first experienced here.

<u>May 4</u> - This date marks the official start of the Shenandoah Valley Campaign directed by Stonewall Jackson.

May 5 - The Battle of Williamsburg occurs with inconclusive results for both sides. General McClellan leads Union forces against General Johnston and Longstreet. Casualties total 2,283 for the North and 1,682 for the South.

May 8 - On this date the Battle of McDowell occurs - a one-day engagement pitting 6,500 Federals against 6,000 Confederates. <u>May 10</u> - Norfolk Navy Yard is destroyed by exiting Confederate forces.

May 10 - A naval engagement is fought four miles upriver from Fort Pillow in Tennessee with the Confederates claiming the victory. May 15 - Confederate guns at Drewry's Bluff turn back the James River Flotilla

approaching Richmond. The squadron had managed to reach within 8 miles of the Confederate capital city.

May 23 - On this date, General Jackson engages Union forces in the Battle of Front Royal. The engagement ends as a Confederate victory with 773 Union elements killed to just 36 Confederates.

May 27 - The Battle of Hanover Courthouse in Hanover County, Virginia takes place.

May 31 - The Battle of Seven Pines (Battle of Fair Oaks) begins in Henrico County, Virginia.

1863

<u>May 6</u> - The Battle of Chancellorsville is over as a Confederate victory. However, the Confederate Army is dealt a blow when it is revealed that Stonewall Jackson is mortally wounded.

May 14 - Battle of Jackson, Mississippi.

May 16 - The Battle of Champion Hill (Baker's Creek).

1864

May 5 - The Battle of the Wilderness takes place across Spotsylvania and Orange counties in Virginia.

May 7 - The Battle of Todd's Tavern (Virginia) takes place between cavalry forces from both sides.

May 11 - The Battle of Yellow Tavern.

May 12 - The Battle of Meadow Bridge takes place.

May 15 - The Battle of Fort Darling or Battle of Drewry's Bluff.

May 18 - The Battle of Yellow Bayou is had in Avoyelles Parish, Louisiana.

May 23 - The Battle of North Anna begins spanning Caroline and Hanover counties in Virginia.

May 31 - The Battle of Cold Harbor begins as part of the Overland Campaign.

1865

May 2 - Acting President Andrew Johnson places a bounty of \$100,000 on the head of Confederate President Jefferson Davis.

May 10 - President Andrew Johnson formally proclaims the end to the years-long war.

May 12 - The last battle of the Civil War is fought at Palmetto Ranch near Brownsville (Texas). The Battle of Palmetto Ranch spans two days.

May 19 - The large Confederate prison-ofwar camp at Tyler, Texas - Camp Ford - is officially closed.

The Battle of Yellow Tavern was fought on May 11, 1864, as part of the Overland Campaign of the American Civil War. Union cavalry under Maj. Gen. Philip Sheridan was detached from Grant's Army of the Potomac to conduct a raid on Richmond, Virginia and challenge Confederate cavalry commander Maj. Gen. J.E.B. Stuart. The two forces met at noon on May 11 at Yellow Tavern, an abandoned inn located 6 miles north of Richmond. Not only did the Union outnumber the Confederates by three divisions to two brigades, it had superior firepower—all were armed with rapid-firing Spencer carbines.

The Confederate troopers resisted from the ridgeline bordering the road low to Richmond for over three hours. A countercharge by the 1st Virginia Cavalry pushed the advancing Union troopers back from the hilltop. As the 5th Michigan Cavalry streamed in retreat past Stuart, a dismounted Union private, 44-year-old John A. Huff, a former sharpshooter, turned and shot Stuart with his .44-caliber revolver, from a distance of 10-30 yards. Stuart died in Richmond the following day. The fighting kept up for an hour after Stuart was wounded.

THE STEAMBOAT ERA ON CYPRESS BAYOU

During the steamboat era from 1840 to 1900, at least 324 different vessels operated west of Shreveport, 288 of which

traveled as far as Jefferson. New settlers were coming to Texas in droves, and it was not uncommon to have 200 people on board along with all sorts of cargo. People and cargo from the steamboats arrived in places like Port Caddo, which serviced Marshall and Harrison County, or Jefferson.

The heyday of the steamboats on Cypress Bayou and the lakes took place during the thirty-three year span between 1840 and 1873. Two events in the mid-1870s would eventually doom the steamboat trade. The most important was the completion of new railroad lines which allowed trains to compete on both price and timeliness for freight hauling. In addition, the second clearing of the Great Raft above Shreveport and the blocking of the distributaries of the Red River caused the lake levels to drop, hindering navigation. Even so, steamboat activity continued at a declining pace on Cypress Bayou and the lakes until the last steamboat made the trip to Jefferson and back in 1905.

On May 24, 1864, Gen. Ulysses S. Grant's forces

continued to advance south of the North Anna River from ground gained the previous day. Union troops were brought up short by Gen. Robert E. Lee's "hog snout line," which forced Grant to divide his force into three parts to attack. Union General Warren's V Corps remained on the Union right, Gen. Ambrose Burnside's IX Corps in the center, and Gen. Winfield S. Hancock's II Corps on the left.

After crossing at Quarles' Mill, an ill-advised Union attack by IX Corps infantry under Gen. James Ledlie was repulsed at Ox Ford. That same day, Hancock pushed his entire corps across the Chesterfield Bridge. In the afternoon, the Federals ran into Confederate skirmishers, sparking a furious firefight that devolved into a hand-to-hand struggle at Hanover Junction. Darkness ended the fighting and Grant ordered his commanders to halt and dig in.

On May 26, Grant withdrew both wings of the army back across the North Anna River. Grant continued his advance on Richmond.

Texas Governor Gregg Abbott Urges "2nd Amendment Sanctuary State" Legislation following President Biden's Gun Control Declaration.

Gov. Greg Abbott called on state legislators to bring him a bill declaring Texas a Second Amendment Sanctuary following executive actions on gun control announced by Joe Biden. After Biden imposed six new measures aimed at making it more difficult for Americans to obtain guns, Abbott shot back that "Biden is threatening our 2nd Amendment rights. "He just announced a new liberal power grab to take away our guns," Abbott declared, adding, "We will NOT allow this in Texas."

"It's time to get legislation making Texas a 2nd Amendment Sanctuary State passed and to my desk for signing," the governor stated.

GILMER'S WATER SUPPLY By G. H. Baird

Up to 1903, Gilmer's water supply was obtained from shallow wells. Each household maintained a

shallow well on its premises from which water for all purposes was supplied. In the business district there were three shallow wells that supplied water for the streets and for the public. One was located on the courthouse square, one on Henderson street near the entrance of Croley Brothers, and one on the west side of the square just off the sidewalk. This well proved to be a popular resort, as it was shaded in the afternoon, and was near the sidewalk. The men would sit on the edge of the sidewalk and whittle in the afternoons, getting their material to whittle on from a nearby grocery store. When the supply gave out, they would stand up and whittle on the well curb. Some of these men became expert whittlers. In a few years the city put in waterworks and these shallow wells were filled up.

Gilmer, Tx, Dec 14, 1887 - The post office at this place was broken into by burglars and robbed of stamps of all denominations. The burglars first broke into the blacksmith shop adjoining and secured what they needed. Then they prized open the front door. After getting into the building they broke the lock of the safe. Postmaster Shrum cannot give the exact amount taken.

Big Sandy, Tx. Feb 2, 1889 - Fatally Stabbed with a Pocket Knife. In a difficulty between W. T. Waddle and S. P. Kay of this place in a drug store this evening, the former was stabbed in the heart with a pocket knife and instantly killed. The two parties involved have families, and the wife of the deceased is now prostrated from the effects. An inquest will be held tonight. **Gilmer, Tx., July 15, 1914** - Killed his Stepfather. Lum Davis last night shot and killed his father, Dick Loving, near here. The cause is not known.

Simpsonville, Tx. Jan 27, 1923 – Mrs. Eve Tillery, wife of W. B. Tillery, farmer, is at liberty on \$1,500 bond today and Charles Pilkington at the point of death as the result of pistol wounds sustained in the court house at Gilmer yesterday just previous to the time set for the trial of Pilkington upon a charge of attempted criminal assault preferred by Mrs. Tillery. The attempted assault is said to have occurred last July.

As Pilkington entered the court house, Mrs. Tillery confronted him drawing a pistol from a blanket in which was wrapped her infant child shot twice, the first bullet lodging in Pilkington's side, the other striking a bystander, J. W. Nelson, inflicting a wound in the arm. Following the shooting, Mrs. Tillery, accompanied by her husband, went to the county attorney's office and was released on bond.

Worry over the scope of the illegal immigration issues has grown among Americans to the point that it has overtaken the coronavirus on the "very big problem" scale, according to Pew Research. Immigrants began surging toward and across the U.S.-Mexico border following

President Joe Biden's 2020 election victory. The crisis has seen record numbers of illegal aliens being detained, thousands of children thrown in cage-like facilities, and families separated. Communities are reportedly being forced to take and care for immigrants even if those communities don't have the resources. The federal government stands accused of not properly testing illegal aliens for COVID-19 and not informing communities that are being strong-armed into housing them about their health status.

COST TO TEXAS

Texas Attorney General Ken Paxton shared that the ongoing crisis at the United States' border with Mexico costs residents of his state "of about \$855 million a year." Paxton, saying his estimate is a "pretty conservative" one, pointed out that Texas is responsible for paying for the education and health care costs of those who come in illegally.

"We've known for decades that illegal immigration costs the state of Texas hundreds of millions of dollars," Paxton advised. "And we put money in to help with that because we have to because we are required to educate people who come here, we are required to take care of their health care costs, we have to deal with law enforcement issues. A conservative estimate is about \$855 million a year. That's just the state of Texas. That does not include the entire nation."






